<u>GOLD STAR DEADLINE -- FEBRUARY 1, 2024</u>: This is the last day to qualify for the Gold Star Club and other awards. Membership counted for these awards must be received at Headquarters by February 1. Adjutants must report their membership awards to Department Headquarters no later than February 15, 2024.
